Good afternoon,

I do not know if you've heard yet, but the Army Corps of engineers is proposing to do emergency dredging of the Kennebec River at Doubling Point and at the mouth of the river at Popham Beach. They propose to dispose of material from Doubling Point at the in-river disposal site adjacent to your property. Attached is information about the dredge. Their request for a Water Quality Certification (i.e., permit application) is expected this week.

DMR is proposing to hold a Public Meeting next Thursday, Feb 24 in Phippsburg.

The two areas proposed to be dredged are the same as those covered under the ten-year permit (also attached).
